GAE PROGRAM FRIDAY, MARCH 18: 10 AM SHARP!!

Laureen DiBisceglie, a past president of SLAMTA in St. Louis, will present "Imagery and Artistry, A visual Presentation" at the upcoming meeting. She has provided the following intriguing description of her program, which uses her photographs of local St. Louis landmarks to illustrate her points.

All the arts are inter-connected and incorporating all in our teaching only enhances the student's performance. Using imagery in teaching broadens the student's perception and understanding of the emotion, the style and structure of a piece. A picture is truly worth a 1000 words! As Goethe once said: "Architecture is music frozen in time."

Following her presentation, we hope to be able to view a Webinar from MTNA Demystifying Baroque and Classical Ornamentation, originally scheduled for February 26, which will now be held on Friday, March 18, at 11:00 AM. George Litterst, nationally known music educator, clinician, author, performer and music software developer, and Ratko Delorko, German pianist and early music scholar, will once again lead this session.

This will mean that the 10:00 meeting must start ON TIME in order not to cut short Laureen's presentation.

AIM INSTRUCTIONS AND REMINDERS (from Joan Witte)

All entry forms can be downloaded from the <u>GAE website</u> or copied from the AIM supplement in the yearbook. Please note that the forms are changed slightly this year. Fees are \$15 per student for Levels 1A, 1B, 1C and 2 only. Higher level students' fees have already been paid with their theory registrations, with the exception of any level 3-12 students who took only the theory exam last year and are taking the performance exam at the same level this year. They will need to pay the \$20 registration fee at this time.

Deadline is midnight March 16. Send another copy of the STUDENT ENROLLMENT AND FEE FORM to Karen Koch, 442 N. Maple St., Trenton, IL 62293, with a check for the total fees made out to Gateway Arch East. Deadline is midnight March 16. When filling out the enrollment form, list ALL dates the student is available, and please refrain from requesting a specific time for the exam, as this makes scheduling very difficult.

As a reminder, all teachers enrolling students at the SWIC testing site are required to judge or monitor at least a half day, regardless of the number of students entered. The new required judging time this year is one half day for every 6 students entered; e.g. 1-6 students = one half day, 7-12 students = 2 half days, etc. Please note that the testing times have changed this year. Morning exams are now 9 a.m.-12:30 p.m., and afternoon exams are 1:30-5 p.m.

Any students requesting a schedule change after the enrollment deadline will be assessed a \$10 rescheduling fee. Teachers should collect all rescheduling fees from students, then mail a check for the total amount to the scheduler, Joan Witte. If a student will be taking a make-up exam after the regular testing dates, the fee is paid to the judge instead. THE DEADLINE FOR ALL RESCHEDULING REQUESTS IS THE WEDNESDAY BEFORE THE TESTING DATE FOR WHICH THE STUDENT IS ALREADY SCHEDULED OR WISHES TO BE RESCHEDULED, WHICHEVER COMES FIRST.
